Requalification 2020

Requalification for returning **revenue operators, maintenance,** and those **student operators** who are actively working toward revenue status will be conducted on March 14th, 15th, 20th, and 21st. All operators will pick a date on the schedule.

You can find the requalification schedule as the first tab on the operations schedule found on the operations webpage, <https://pa-trolley.org/operations-department/>. Class size is limited to fifteen (15) operators.

The cost is \$10.00. However, any operator that operated more than 10 days in 2019 does not have to pay the \$10 fee. We will be collecting the \$10 fee on the day of your Requalification.

This year you must have your Criminal and Child abuse background clearances turned in before you will be permitted to participate in requalification. You may turn in your forms on the day of requalification. If you have any questions you may contact our volunteer coordinator, Kaylee Horvat, at volunteer@patrolley.org or 724-228-9256 x313. Kaylee is not full time so please allow a few days for her to respond.

If you turn 65 before May 1, you must submit a certificate of visual acuity and do so every other year thereafter. (65-67-69-71-73-75-etc.)

If you are unable to attend any of the requalification dates you must contact the operations manager at operations@patrolley.org before March 2020. We are asking for maintenance operators to sign up for March 14th or March 20th to receive special instruction.

Background Clearances Due: April 1st

Many of you are aware that last year the Pennsylvania Trolley Museum Board approved Policy 47 Background check/PA CPSL Compliance Policy.

This policy is in accordance with Pennsylvania's Child Protective Services Law (CPSL) and requires all employees, prospective employees, volunteers, and prospective volunteers, age 18 and older, to obtain and provide to the Volunteer Coordinator at the Pennsylvania Trolley Museum all clearances as set forth in the CPSL, and provide updated clearances every 60 months per CPSL.

We ask that you submit your updated clearances prior to the Museum opening in the spring. **Please send your clearances to me by April 1, 2020.** The required clearances and a link where you can obtain them are listed below:

Act 33 - Child Abuse History clearance from the Pennsylvania Department of Human Services

Act 34 - Criminal History Report clearance from the Pennsylvania State Police (PSP)

FBI Criminal Background Check (fingerprint check) clearance (if you've been a PA resident for less than 10 years)

If you reside out of the state of Pennsylvania, you are required to obtain the equivalent background checks from the states in which you reside.

A copy of your clearances can be mailed to me at the office, sent via email to volunteer@patrolley.org, or dropped off in person at the office.

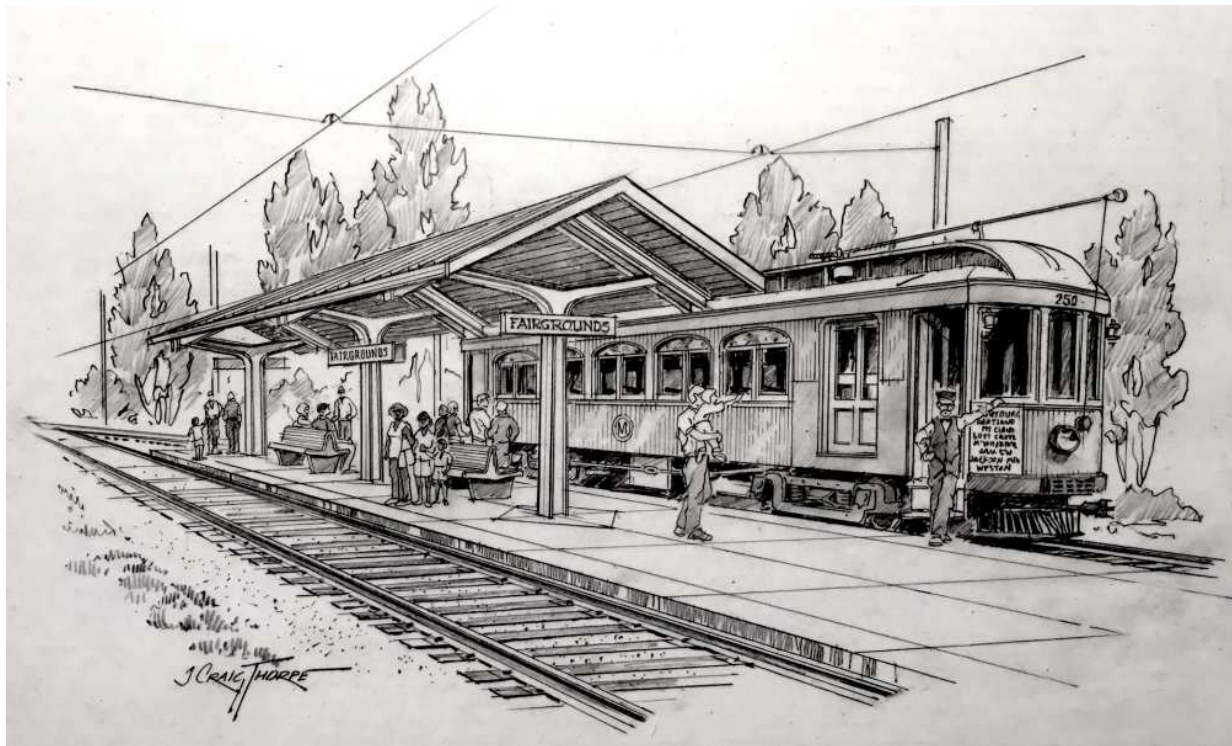

Fairgrounds Phase III Project

The next phase of improvements is underway at Fairgrounds Stop. Following up on the new bridge (Phase I) and the greatly-expanded platform and passing siding (Phase II) we are now underway with the construction of a canopy over the in-bound end of the Fairgrounds platform.

First some background. We knew we wanted to have a canopy over the platform, but the Phase II project, (funded by the County and PennDOT) didn't have sufficient budget. So, all we could afford was facilitating the canopy as a future project. Remember those diamond-shaped patterns in the platform concrete? They're not merely decorative. They're "knock-out" panels to facilitate the installation of columns for the canopy.

As with many PTM projects, the job got underway with an unexpected phone call – this one from the Museum's friends at the Pittsburgh History & Landmarks Foundation, the original owners of Station Square. They had a miscellaneous collection of eclectic architectural artifacts stored across from the lower station of the Duquesne Incline but needed to get them out of there. Anything we wanted was ours for the taking. Were we interested?

Fairgrounds Phase III Project - continued

We investigated and discovered that among the artifacts were nine T-shaped columns that once supported the canopies over the P&LE Railroad station platforms along with some other structural stringers which spanned from column to column. These items had become surplus when Station Square was remodeled a decade ago, requiring a portion of that canopy to be removed. Bingo! This discovery solved two problems. In addition to Fairgrounds, we also want to have a canopy over the platform adjacent to the future Welcome & Education Center. The available steel is just enough to satisfy the East Campus needs plus provide a canopy over half the length of Fairgrounds. So, we relocated the steel Tees from Station Square to temporary storage at Camber Corp's steel fabrication plant in Butler. We also did a quick redesign of the Fairgrounds platform to change the size and locations of those diamond knock-outs.

Fundraising for the project, facilitated by the artist's rendering below, has gotten us to the point where construction can begin. At this writing, Camber has modified

and rehabilitated the legacy steel, adapting it to our needs while retaining its historic character. Bioni Drilling (who had built the Fairgrounds bridge) has built reinforced concrete foundations for the columns. During February and March, Bioni will erect the skeletal structural steel and the concrete platform restored in the knock-out panels around the Tee columns.

The next step will be installation of a roof atop the structural steel. That's currently on hold while fundraising continues. When the roofing contractor is on site, it will be necessary to lock-out the trolley power since he and his equipment will be too close to the wires. Obviously, that step needs to be closely coordinated with trolley operations. For both that reason and fundraising, the canopy roof might not be in place until the Fall of this year.
